Special and/or sensitive personal data that we process

Our website and/or service does not intend to collect data about website visitors who are younger than 16 years of age. Unless they have permission from parents or guardians. However, we cannot check whether a visitor is older than 16. We therefore recommend that parents be involved in the online activities of their children, in order to prevent data about children from being collected without parental consent.

For what purpose and on what basis do we process personal data

Healthcare Plaza Europe. processes your personal data for the following purposes:

- To be able to call or email you if this is necessary to provide our services

- To deliver goods and services to you
- Analyzing behavior on the website in order to improve the website.

When you provide us with information, this can be followed up by our customer service by e-mail or in certain cases by telephone. In the case of e-mail, you can expect an e-mail when you request a brochure. Based on your interaction, you may receive a few more emails. If you do not like this, you can unsubscribe at any time.

Automated decision making

Healthcare Plaza Europe does make decisions based on automated processing on matters that could have (significant) consequences for people. These are decisions taken by computer programs or systems, without a human being involved (for example an employee of Healthcare Plaza Europe). Healthcare Plaza Europe uses the following computer programs or systems: wordpress . We use these systems to send relevant messages to offer to the user.

How long we keep personal data

Healthcare Plaza Europe does not store your personal data for longer than is strictly necessary to achieve the purposes for which your data is collected. Personal data will not be stored on bodyplaza.eu for longer than one month. Personal data will continue to be stored by us until cancellation by the customer or surviving relatives. This has to do with being able to provide adequate service on the delivered products.

Sharing personal data with third parties

Healthcare Plaza Europe does not sell your data to third parties and only provides it if this is necessary for the execution of our agreement with you or to comply with a legal obligation. We enter into a processor agreement with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. Healthcare Plaza Europe remains responsible for these processes.

Cookies, or similar techniques, that we use

Healthcare Plaza Europe used functional , analytical and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website.

Healthcare Plaza Europe uses cookies with a purely technical functionality. These ensure that the website works properly and that, for example, your

preference settings are remembered. These cookies are also used to ensure that the website works properly and to optimize it.

We also place cookies that track your surfing behavior so that we can offer customized content and advertisements. On your first visit to our website, we already informed you about these cookies and asked permission to place them.

You can unsubscribe from cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information previously stored via the settings of your browser.

You have the right to view, correct or delete your personal data. You can send a request for access, correction, deletion, data transfer of your personal data or request for withdrawal of your consent or objection to the processing of your personal data to info@healthcareplaza.eu. To ensure that the request for access has been made by you, we ask you to enclose a copy of your proof of identity with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN) black in this copy. This is to protect your privacy. We will respond to your request as quickly as possible, but within four weeks.

Healthcare Plaza Europe would also like to point out that you have the option to file a complaint with the national supervisory authority, the Dutch Data Protection Authority, if your complaint is not handled with care by Healthcare Plaza Europe.

How we protect personal data
